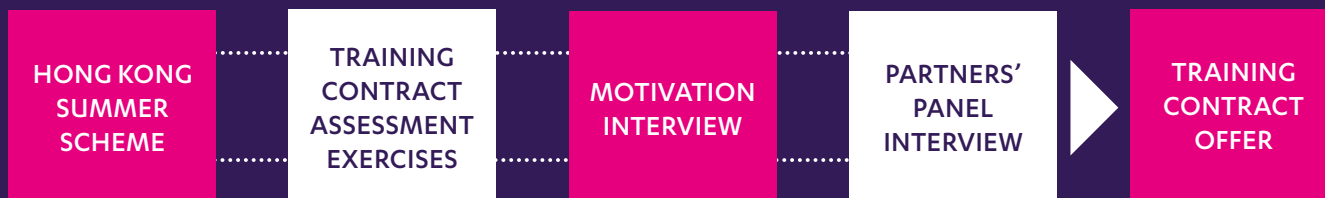
# THE SELECTION
